I, the undersigned applicant, hereby certify that (please initial and or provide information in each section where applicable):

_____ No minor has been charged and convicted of unlawful consumption of alcohol on the premises of the off-track facility or, with respect to multiple use facilities, anywhere on the premises of the multiple use facility during the past year.
