CALL TO ORDER

I. PRELIMINARY GENERAL BUSINESS

1. Announcements

Mr. Welch announced a planned event at the new open space on McMillan Mesa on Saturday, May 19 beginning at 9:00 am.

Ms. Leid introduced herself as a member of the City's Transportation Commission, and a former member of the Citizen Transportation Tax Commission. She acknowledged the letter from the PAC to the City Council regarding the tax renewal

recommendation, and reported that the Council has not made a final decision. They will likely decide at the end of May or the beginning of June, and are awaiting the results of a citizen survey. She said she would like to open the lines of communication between the PAC and the Transportation Commission.

2. Public Comment

3. Approval of Minutes

Ms. Norris made, and Mr. Schwartz seconded, a motion to approve the minutes of the regular meeting of March 8, 2018. The motion was approved unanimously (5-0).

II. OLD BUSINESS

1. Active Transportation Master Plan

Mr. Ince demonstrated a draft interactive FUTS planning map. The Committee offered several thoughts:

- Where property rights are needed for future trails, it would be useful to provide some indication of how difficult the acquisition might be.
- The map has good information, but it may be too much detail for the public.
- The most common question from the public is when will the trail be built. A simple visual map expressing the anticipated timing of trails would answer the question.
- The map is not intuitive, but would benefit from a short tutorial or splash screen to explain how the map works and what information is available.
- There is a danger in providing too much information and overwhelming the public. Information should be limited to that which is most useful.
- It might be helpful to break the map into different themes.
- Is it possible to create a truly interactive map, on which the public can leave comments.

The Committee suggested providing a link to the interactive map from the City's website.
