In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.

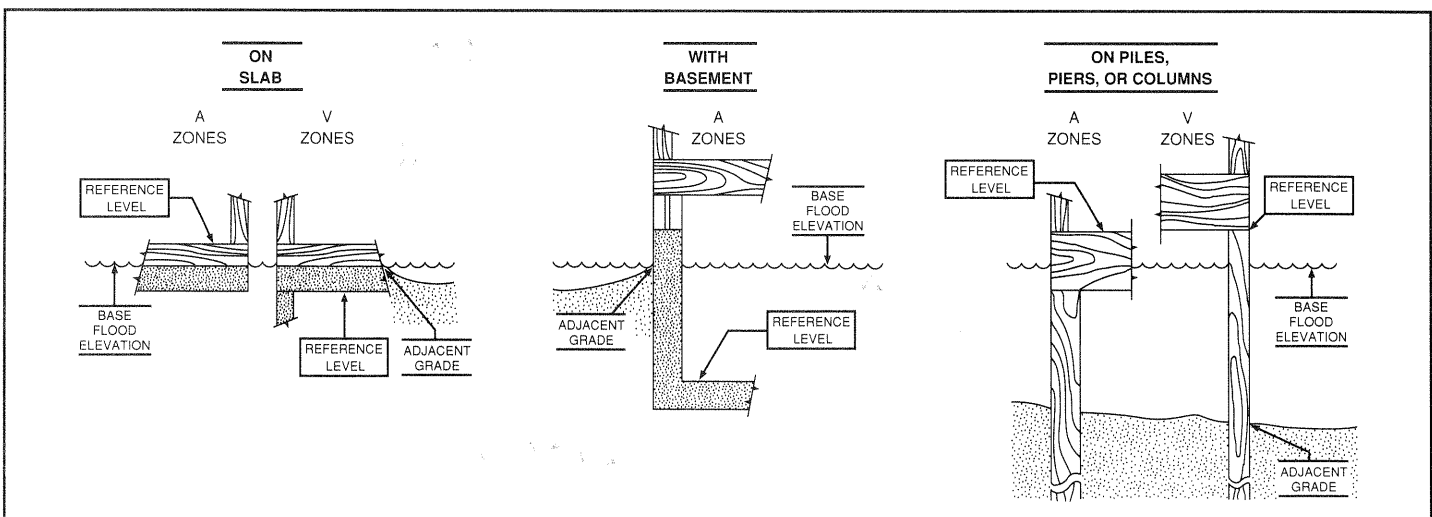

COMMENTS: Buildings first floor includes an auditorium with a sloping floor. Top = 6904.9 Bottom = 6903.0 (reference level floor). Lowest grade immediately adjacent to building (6900.0) is at the opposite end of the building from the auditorium, and reference floor elevation at this location is approximately 6904.9.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
